## SOBER LIVING HOUSE RULES & RESIDENT AGREEMENT

---

### **Mission Statement**

All Under One Roof, LLC exists to provide a safe, structured, recovery-focused living environment where residents are supported through accountability, mentorship, sobriety, personal growth, and community living.

These rules exist to protect your recovery, your freedom, and the safety of everyone in the home.

### **I. SOBRIETY & RECOVERY**

#### **1. Zero Tolerance Policy**

This is a completely drug-free and alcohol-free home. Residents may be subject to random drug and alcohol screenings at any time. Refusal to submit to screening will be treated as a positive result.

#### **2. Prescription Medications**

All prescription medications must be disclosed to staff upon admission or within 24 hours of receiving a new prescription.

#### **3. Mandatory Mentorship Participation**

Participation in The Rise Group mentorship program is mandatory for all residents. Residents are expected to attend mentorship sessions, recovery meetings, classes, and house meetings consistently.

### **II. CURFEW & ACCOUNTABILITY**

#### **4. Curfew**

Sunday–Thursday: 11:00 PM

Friday–Saturday: 12:00 AM

Exceptions may be approved for verified employment, overnight work shifts, emergencies, or prior staff approval.

#### **5. Sign-In / Sign-Out**

Residents must sign in and out whenever leaving or returning to the property and provide destination, expected return time, and contact number.

#### **6. Overnight Passes**

Overnight absences require prior approval from house management.

### **III. PROGRAM EXPECTATIONS**

#### **7. Cooperation with Staff**

Residents must cooperate respectfully with staff, mentors, house managers, inspections, room checks, and program expectations at all times.

#### **8. Employment & Productivity**

Residents are expected to maintain employment, seek employment, attend school, volunteer, or participate in approved recovery-focused activities.

#### **9. Financial Responsibility**

Program Fees: \$200 Entry Fee (non-refundable) \$175 Weekly Program Fee \$700 Monthly Equivalent Payments may be made weekly, biweekly, or monthly.

Failure to maintain payments without approved arrangements may result in disciplinary action or discharge.

#### **IV. CONDUCT & COMMUNITY STANDARDS**

##### **10. Respect**

Residents must treat staff, mentors, neighbors, visitors, and fellow residents with respect at all times.

##### **11. Visitors**

Visitors are only allowed with prior staff approval. Visiting hours are 12:00 PM – 8:00 PM. Overnight guests are not permitted.

##### **12. Cleanliness & Chores**

Residents are responsible for keeping rooms clean, completing chores, maintaining hygiene, and helping maintain common areas.

##### **13. Quiet Hours**

Quiet hours are 10:00 PM – 7:00 AM daily.

##### **14. Weapons**

Weapons of any kind are prohibited on the property and may result in immediate discharge.

#### **V. TRANSPORTATION POLICY**

##### **15. Transportation Rules & Waiver**

Residents utilizing transportation services must arrive on time, wear seatbelts, respect drivers and vehicles, and follow transportation schedules and instructions.

#### **VI. ZERO-TOLERANCE VIOLATIONS — IMMEDIATE DISCHARGE**

The following may result in immediate discharge: Drug or alcohol use Possession of drugs, alcohol, or paraphernalia Tampering with or refusing a drug screen Violence or threats of violence Possession of weapons Theft Intentional destruction of property Unauthorized overnight guests Criminal activity **RESIDENT ACKNOWLEDGMENT**
